Course description and objectives:

The objective of this course is to develop an understanding of basic concepts and mechanisms in microeconomics. Among others, we will answer the following questions: How do firms and households make production and consumption decisions? How do market mechanisms work and when do they fail? What is the role of government regulations and taxation? Why do countries trade? We will review these and other questions through the lens of both microeconomic theory and real world data.

Requirements and prerequisites:

There are no prerequisites for this course. Good understanding of basic algebra will be helpful.

Required book, web-platform and clickers :

The required text is: { *Paul Krugman and Robin Wells, Microeconomics, 6th edition, 2021, Worth Publishers*. In addition to the text you are required to sign up for **Achieve** to complete weekly assignments.

To keep the cost of your course materials as low as possible and access to those materials as convenient as possible, we have collaborated with the CU Book Store and the publisher to deliver those materials through a program called "Inclusive Access", which will appear on your tuition and fee bill as "Day 1 Digital Access".

What does this mean for you?

1. You will receive access to all your digital course materials on the first day of classes through your Canvas page.

2. You will see a "Day 1 Digital Access" charge on your tuition and fee bill for: \$101.26 This is a low price discounted by the publisher, and not available outside this course
3. You have the option to opt out. This means: you won't pay for anything, but you lose all access to the course materials, including homework manager
 - You can opt out by using a link in a reminder email you will receive with the subject heading "Day 1 Digital Access".
 - You must opt out no later than February 1st 2023, otherwise you will be charged for the materials.
4. Please keep in mind that "opting out" means that your access to these materials will be turned off.

Achieve Platform

Achieve Platform allows you to access ebook and homework assignments. To gain access you will need to sign up in CANVAS. You can find the instructions on how to sign up on CANVAS under the "Achieve Instructions" tab. Every week you will need to complete one homework assignment. The assignments will become available on Monday in the "Assignment" section. The deadline for each assignment will be announced in class and posted on CANVAS homepage. There will be no make-up assignments for missed homework. I will discard one homework assignment with the lowest score when calculating your final grade. Achieve Platform is also used for extra-credit assignments and contains non-graded pre-class videos.

Course structure:

The course will consist of lectures, in-class clicker questions, weekly homework, and recitations:

- Attendance: It is essential for you to attend the lectures to understand the material.
- Clicker questions: Your answers will be graded and will count toward the final grade. You will get 2 points for a correct answer, 1 point for an incorrect answer, and 0 for no answer. I will discard 10 answers with the lowest score in the end of the semester.
 - { Each class will have 1 group clicker question. Students will be able to discuss and coordinate their answers. I will award 2 bonus points if 70% of students in class answer correctly.
- Homework: There will be weekly homework assignments. Each assignment will be due by the end of the week, i.e., by midnight of the corresponding Sunday. There will be no make-up assignments for missed homework.
- Recitations: There will be weekly recitations. They will start the second week of classes.

Recitations:

Recitations will begin the **second week** of classes. It is essential for you to attend the recitations to grasp the material. TA's conducting recitations will grade your performance which will count toward the final grade. You must attend the recitation to which you have been assigned.

Office Hours & Communication Policy:

You can find the schedule for office hours on CANVAS under the "Office Hours" tab. When contacting me or TA's by email, make sure to conduct communication in a professional manner. This includes using your

colorado.edu email address and stating your name and section number. Before writing an email, read the syllabus and make sure that it doesn't have the answer to your question.

Exams and grading:

We will have two in-class midterms and a cumulative final exam. There will be no make up exams. The weights of the final grade are as follows:

Final exam:	35%
Maximum of Midterm I and Midterm II:	30%
Clicker questions:	10%
Homework assignments:	10%
Recitations:	10%
Participation:	5%
Total:	100%
Extra Credit:	2%

When calculating the final grade for the class, I will use the maximum score you get for either of the two midterms. Hence, if you miss one of the midterms, the score for this test will be automatically dropped. However, if you miss both midterms due to a medical reason (you must inform me prior to each midterm), the weight of the midterm will be shifted to the final exam. There will be no make up exams or extra-credit assignments. If your scores for both midterms are in top 5% of the class, you will get 10% added to your final exam.

Extra credit assignments are not required. Only complete them if you need additional practice/help with your reading or you feel that you will need extra points. Extra-credit points can account for a maximum of 2% of your total grade. Extra-credit assignments will have deadlines and are accessible via *Achieve*.

Rules of conduct:

This is a large class and we will observe a set of classroom rules to ensure effective learning environment.

- Arrive on time & do not leave early. Do not start packing before the end of class.
 - Students will check in at 11:00 am and check out at the end of each class using clickers. Special instructions will be provided in class. (1 clicker point will be awarded for checking in/out on time).

All students start the semester with 5% for participation. If you break (1) and(2) below, your participation score will decline to 0%. These regulations hold for both lectures and recitations.

1. No laptops, no cellphones.
 - The use of electronic devices is generally not permitted. There is now significant amount of research showing that the use of laptops, phones and other electronic devices is detrimental to learning. If you must use an electronic device for taking notes due to a medical condition please consult with me.
