### **Course Description:**

In this course, we will study the theories, policies, and institutions of international trade and fin economic, political, and social forces underlying many of the issues involved in international eare complex, multi-faceted, and dynamic. They cannot be fully or easily analyzed in a profess lifetime, much less a one-semester course. They do, however, lend themselves extremely well thinking and rational inquiry, which are the guiding principles of this course. Our goal is to be remain informed about issues related to international economics and, even more importantly, a ability to think about complex issues in a logical objective manner. Thinking critically is what to differentiate between the illogical and the sensible, between the misleading use of statistics, anecdotal evidence, and the reasonable presentation of information.

We will use several different models to analyze the different topics covered. These models are largely on diagrams and some mathematics. You will be given problem sets that will be instruyour preparation for exams. I will cover all necessary material to complete these problem sets for exams in class.
